

Policy Asks : Election 2022

First Nations Justice

Protect Country

- Agree that Traditional Owners must give consent to gas mining projects and infrastructure on their lands.
- Double the funding for Indigenous Rangers Working on Country Programs.
- Amend the 'water trigger' under the Environment Protection and Biodiversity Conservation Act 1999 to include protection for water sources from shale gas projects.
- Fund adaptation programs for the Torres Strait Islands to support communities to adapt to climate impacts and stay on their islands.
- Meet with Torres Strait Traditional Owners to witness the impacts of climate change first hand within the first 100 days of being elected.
- Commit to a permanent ban on shale fracking.
- Implement all 135 recommendations from the 2018 Scientific Inquiry into Hydraulic Fracturing in the Northern Territory (the Pepper fracking inquiry).
- Co-design a Federal Heritage Act with Aboriginal and Torres Strait Islander people, that includes:
 - a review of all Aboriginal Heritage areas that would turn into a national register of tangible and intangible cultural heritage sites including those already destroyed;
 - veto power for Traditional Owners to refuse consent to projects impacting cultural heritage; and
 - harsher penalties for corporations who destroy cultural heritage, giving Traditional Owners the right to pursue damages.
- Review of the Native Title Act 1993.

Reduce the harm of incarceration

- Audit the recommendations from the 1987 Royal Commission into Aboriginal Deaths in Custody, and implement the recommendations that haven't yet been implemented.
- Abolishing Mandatory Sentencing.
- Divert funding away from the police, and towards increased social services.
- Invest in community based initiatives and alternatives to detention for juveniles.
- Commit to more Community Liaisons.
- Commit to having unarmed police patrols in Aboriginal communities.
- Implement all 227 recommendations from the 2017 Royal Commission into Detention and Protection of Children in the Northern Territory.

End the housing crisis

- Restore critical funding partnerships between state and federal governments for remote Aboriginal community housing.
- Spend\$5 billion over 10 years to address overcrowding and homelessness in Aboriginal communities by:
 - Building new public housing

 - Ensuring all new builds are climate adaptable housing
 - Ensuring air conditioning and insulation is mandatory in existing and new homes
 - Removing reliance on diesel in communities for housing energy use
 - Ensuring all homes have rooftop solar of community powered renewables
 - Ensuring safe drinking water for all remote communities
 - Investing in upgrades for roads in remote communities

Secure and affordable renewable energy

- Establishing a Community Renewables Program to support solar in regional and remote communities.
- Review the current training programs to ensure they are focused on growing the skills of the local labour force.
- Initiate a reverse auction process for renewable energy power purchase agreements in Aboriginal communities.
- Support Torres Strait Islander communities to build community-owned renewable energy.

Truth Telling

• Establish a national First Nations Truth Telling Commission in this term of Parliament.

Better healthcare for all

- Commit to significant funding to address the suicide and mental health crisis, including:
 - Increasing the number of mental health workers in communities
 - Increasing youth programs.
- Make the health system more resilient for communities by:
 - Significantly investing in health centres outside of the major centres, including aged care and mental health services
 - Increasing the number of permanent staff and beds in communities.
- Work with Aboriginal communities and peak organisations around the current COVID-19 crisis, and future crises.
- Increase funding for COVID-19 support in remote communities.

End the Northern Territory Intervention

• Abolish the Northern Territory Intervention (Stronger Futures in the Northern Territory Act 2012).

Real jobs for our community

- End the racist and punitive Community Development Program.
- Investing in real jobs for remote communities.
- Abolish the Cashless Debit Card.

Affordable food and essential items

- Address the food shortages in remote communities by shortening the supply chain.
- Implement a watchdog to monitor and crack down on price gouging in remote communities.
- Invest in communities' ability to create their own food supply, through initiatives such as community gardens.
- Support Aboriginal communities to own, control and operate food stores.

Inequality

Better healthcare for all

- Will you support permanently increasing federal funding to healthcare from 45% to 50% (compared to state funding) in order to boost staffing and resources?
- Will you commit to making rapid antigen tests free for everyone?
- Will you permanently expand the number of subsidised mental health sessions claimable under Medicare?

A fairer future

• Increase the rate of JobSeeker and Disability Support Pension to the Henderson Poverty Line or above.

Media & Democracy

Cleaning Up Our Democracy

- Support a Federal Integrity Commission with proper funding, public hearings, strong investigative powers, a broad scope, and the ability to make public findings of corruption.
- Protect voting rights for all Australians by blocking any attempt to introduce voter identification laws.

Free & Fair Media

• Guarantee our public broadcasters are fully funded, including a restoration of government budget cuts since 2013, and a stable five-year funding cycle that increases to meet the needs of our communities.

- Champion the independence of the ABC and the SBS by fighting political interference, including an end to politicised board appointments, tied-funding grants, and indexation freezes.
- Support a Royal Commission into media concentration, regulation and Newscorp's power and influence.
- Support an overhaul of media regulation laws that have entrenched media concentration, including restoring caps on media ownership, a fully funded media regulator and an investment in independent and local news journalism.

Climate Justice

Replace burning coal and gas with 100% clean, renewable energy this decade

- Deliver 100% clean electricity from sun, wind, and other renewable power and storage by 2030.
- Reduce climate pollution by 2030 with targets that at least match major economies like the United States, the United Kingdom and the European Union.
- Reach zero emissions by 2035.
- Commit to no new approvals of coal, oil or gas projects.
- Deliver a national plan to clean up transport prioritising public and active transport, and replacing fossil fuel vehicles with electric vehicles.
- Create energy independent communities funding a community renewable energy program and powering schools, hospitals, government offices, public and social housing, remote First Nations communities, sporting clubs, halls and libraries with affordable, clean energy by 2025.
- Roll out a national household energy upgrades program to older homes to support electrification, solar, EV chargers, batteries, better appliances, heat pumps, and insulation so people can live comfortably in low pollution homes that are cheap to run.
- Reform the National Construction Code to make new buildings all-electric, gas-free, well insulated and designed so they are liveable, affordable to run and less polluting. And implement minimum energy efficiency standards for rental properties.
- Establish a National Transition Authority to: coordinate economic diversification for communities formerly reliant on fossil fuels; ensure communities share in the benefits of new renewable energy projects; and support thousands of well-paid jobs in local manufacturing of clean infrastructure.

Fund the future, not public subsidies for coal, oil and gas corporations

- Rule out new subsidies for coal, oil and gas.
- Rule out new subsidies for carbon capture and storage (CCS) linked to coal, gas or oil projects and fossil-fuel derived hydrogen.
- Review all federal fossil fuel subsidies by the end of 2022.
- Phase out all existing public funding for coal, oil and gas.
- Reform the Northern Australia Infrastructure Facility (NAIF) to explicitly ban it from investing in new fossil fuel infrastructure.
- Ensure the Clean Energy Finance Corporation (CEFC) and the Australian Renewable Energy Agency (ARENA) only fund renewable energy, and double their funding.

Support people and communities impacted by climate damage

- Invest in community-level disaster preparedness and response including permanent, funded, community resilience hubs in every local government area in vulnerable parts of the country; and prioritise funding for building resilience before a disaster strikes.
- Increase the accountability of the National Recovery and Resilience Agency and the Emergency Response Fund, so that they deliver community-led, trauma- informed, people-centred solutions commensurate with the scale of repeat climate disasters.
- Ensure that Traditional Owners must give consent to gas mining projects and infrastructure on their lands.
- Commit to a Federal Heritage Act that includes veto power for Traditional Owners to refuse consent to projects impacting cultural heritage.
- Will you commit to amending the 'water trigger' under the Environment Protection and Biodiversity Conservation Act 1999 to include protection for water sources from shale gas projects?
